An Opportunity for Public Input was extended with no one present.

Motion to approve the minutes of the November 20th meeting was made by Fr. Kevin Richter and seconded by Gary Wiskus. All ayes. The motion passed.

Final Audit Report, 2017-2018 Fiscal Year

Nick Stanley of Schnurr & Company, LLP presented the 2017-2018 audit report to the board. Tom Brincks made a motion to approve the final 2017-2018 audit report from Schnurr & Company, LLP, seconded by John Evans. All ayes. The motion passed.

Marketing & Enrollment Management

In Susie Hulst's written report she stated that the total enrollment is 1,149. Quick Stats for Kuemper Conversation cards were updated and given to the Board.

Development/Fundraising - Foundation

Sharon Olerich's written report stated that the total pledges for the *Kuemper Tomorrow* Capital Campaign are \$5,260,377.The cash balance is \$257,310. The Sponsor-A-Student has collected \$3,949 so far this year. The 2019 Kuemper Ball will be Saturday, April 27th. The Kuemper Catholic School Foundation sponsored the annual Faculty and Staff Christmas Party at the Bowling Alley. The Foundation members personally will distribute \$200 Advent Gifts to all employees. The teacher gifts are sponsored by the Teacher Salary Enhancement Fund and the non-certified staff gifts are sponsored by the general Foundation. Nic Prenger from Prenger Solutions Group was here for a final report on his review of Kuemper's fundraising operations, especially on-line.

Finance & Budget

Kris Collison reviewed the general fund income and expenses for November and the 2018-2019 Working Fiscal Year Budget. There was discussion and concerns on the Parish investments.

- the adoption of the 1000 & 3000 KCSS Policies (with the regulation after 1100.4 be formatted 1100.4R.) with the 1st reading in December, waive second, final approval in January.

- 2. Catholic Identity December 4
- A report on a Kuemper and Diocesan collaboration with the Center for Catholic Education and Catechesis/Evangelization at Aquinas College in Nashville, Tennessee was presented at the Catholic Identity Committee meeting by Father Brian Feller and assisted by Kathi Milligan. The Dominican Sisters have a program that unites the dual integration of faith and school. This program for K-8 is in a 3-year rotation of Faith, Hope & Charity. Each grade will receive a uniquely prepared year-long program which is age appropriate, not repeated but a new program guided by Sr. Mary Michael Each month a new virtue and Saint is highlighted, appropriate for the age level. The Catholic Identity committee recommended that within the 2019-2020 budgetary decisions and/or donations provide funds for the support in partnering with the Centers for Catholic Education and Catechesis/Evangelization program.
 - 3. Buildings & Grounds December 10
- Tom Brincks made a motion to accept the recommendations from the Buildings & Grounds Committee to replace the siding on the KHS south side using KCSS capital projects funding; and to approve sanding and refinishing the KHS gym floor pending funding from the Booster Club.
